



## Wine (Exemption from Wine Standards Management Plan) Notice No. 2 2008

## Notice

### 1 Title

This notice is the Wine (Exemption from Wine Standards Management Plan) Notice No. 2 2008.

### 2 Commencement

This notice comes into force on 24 December 2008.

### 3 Interpretation

- (1) In this notice, unless the context of the notice otherwise requires-

**Act** means the Wine Act 2003

**Food safety programme** means an approved food safety programme within the meaning of the Food Act 1981, being a programme whose adoption gives rise to an exemption from the Food Hygiene Regulations 1974 under Part 1A of the Food Act 1981

**NZFSA** means the department of state known as the New Zealand Food Safety Authority.

- (2) Any term or expression that is defined in the Act and is not defined in this document has the same meaning as in that Act.

### 4 Application

- (1) This notice applies to all winemakers listed in schedule 1 of this notice.
- (2) For the avoidance of doubt, nothing in this notice effects the requirement to comply with regulations 7 and 8 of the Wine Regulations 2006 and clause 6 of the Wine (Specifications) Notice 2006.

### 5 Exemption

A winemaker listed in schedule 1 of this notice is exempted from operating under a registered wine standards management plan (an exempted winemaker) for the winemaker's winemaking operations if the winemaker is complying with the conditions specified in clause 6.

### 6 Conditions

- (1) An exempted winemaker must operate under an approved food safety programme or under the Food Hygiene Regulations 1974 in relation to their winemaking operations.
- (2) An exempted winemaker must notify NZFSA, in writing, as soon as possible when the nature or scope of the winemaker's operation changes.

- (3) An exempted winemaker must not produce grape wine for export from New Zealand.

## 7 Period of Exemption

This exemption expires on 1 July 2012.

## 8 Revocation

This notice revokes the Wine (Exemption from Wine Standards Management Plan) Notice 2008 dated 7 November 2008.
